

## **REQUIREMENTS FOR ANNUAL PARKING PERMITS**

### **RESOLUTION NO. 2015-24 OF THE CITY OF CERRITOS PROVIDES SUBSTANTIALLY AS FOLLOWS:**

- (a) Annual Parking Permits will be issued to passenger vehicles only.
- (b) Annual Parking Permits may not be issued to motor homes, R.V.s, or to commercial vehicles. This would include, but not be limited to, vehicles with signs, logos, racks, or ladders.
- (c) Residents of a single-family dwelling with a two-car garage must have a minimum of four (4) passenger vehicles, all registered to the applicant household. A driver's license must be provided to match the name and address of the registered owner of the vehicle.
- (d) Residents of a single-family dwelling with a three-car garage must have a minimum of five (5) passenger vehicles, all registered to the applicant household. A driver's license must be provided to match the name and address of the registered owner of the vehicle.
- (e) Residents of a condominium must have a minimum of three (3) passenger vehicles, all registered to the applicant household. A driver's license must be provided to match the name and address of the registered owner of the vehicle.

### **REQUIREMENTS FOR ADDITIONAL ANNUAL PARKING PERMITS ARE AS FOLLOWS:**

- (a) Residents of a single-family dwelling with a two-car garage must have a minimum of six (6) passenger vehicles and five (5) licensed drivers, all registered to the applicant household. A driver's license must be provided to match the name and address of the registered owner of the vehicle.
- (b) Residents of a single-family dwelling with a three-car garage must have a minimum of seven (7) passenger vehicles and six (6) licensed drivers, all registered to the applicant household. A driver's license must be provided to match the name and address of the registered owner of the vehicle.
- (c) Residents of a condominium must have a minimum of four (4) passenger vehicles and three (3) licensed drivers, all registered to the applicant household. A driver's license must be provided to match the name and address of the registered owner of the vehicle.
